Description: Non Instrumented Drug Testing Devices (NIDT) (test cups)

Estimated Monthly Quantity (EMQ): 550 monthly units (approximately 6600 annually)

1. The NIDT's <u>must</u> include the following drugs with the cut-off levels outlined below, which are set by the Administrative Office of the U.S. Courts:

Cannabinoids 50 ng/ml

Benzoylecgonine (Cocaine) 150 ng/ml

Amphetamine/Methamphetamine 500 ng/ml

Opiates (Morphine, 300 ng/ml

Codeine,

Hydromorphone (Dilaudid),

Hydrocodone)

Oxycodone/Oxymorphone 100 ng/ml

2. Price quotes <u>must</u> include a statement confirming the NIDT's test at the above-listed cut off levels.

3. In addition to the aforementioned drugs and cut-off levels, the NIDT's should also include the following drugs with **preferred** cut off levels:

Ethyl Glucuronide 500 ng/ml

Benzodiazepines 200 ng/ml

Methadone 200 ng/ml

Fentanyl 2 ng/ml

Gabapentin 100 ng/ml

Synthetic Cannabinoids 25 ng/ml

If the vendor can provide a device with similar configurations, or possibly other drugs, the U.S. Probation/Pretrial Services would be open to consideration if the cost is competitive.

- 4. The NIDT's must have integrated temperature strips and adulteration panels.
- 5. The vendor will provide training to U.S. Probation/Pretrial staff as needed or requested.
- 6. Price quotes are to include shipping/delivery and training (if applicable).
- 7. Price quotes must be for the cost per "unit," or individual NIDT.
- 8. Specifications must be equal to, or better than, the product described.
- 9. The Delivery Address for this purchase will be six USPO locations in the District of North Dakota (Belcourt, Bismarck, Devils Lake, Fargo, Grand Forks and Minot), as well as nine contracted vendor sites in the aforementioned communities (plus Jamestown and Dickinson).
- 10. U.S. Probation & Pretrial Services is unable to pay for products/supplies in advance. The vendor will submit invoices after services rendered or supplies delivered.
